# UPDATE - GENERAL MEETING 28 MAY 2020

To facilitate such participation, voting on each Resolution will occur by a poll rather than a show of hands.

### ANNUAL GENERAL MEETING

As advised in our announcement on 8 May 2020, the Directors have resolved to defer the Annual General Meeting to July 2020 to give shareholders and the Board the best opportunity to attend in person. The deferral of the AGM is in line with ASIC's 'no action' position announced on 20 March 2020. The Company continues to assess the situation and a notice of AGM will be sent to shareholders once a date for the meeting has been set.
